SECTION VII: PREVENTIVE MEASURE

PERSONAL PROTECTIVE EQUIPMENT / ENGINEERING CONTROLS
Wear natural rubber or other impervious gloves and splash goggles. If indicated by conditions of use, impervious apron, face shield and other protective equipment should be considered in order to minimize contact with this product. Eyewash stations and washing facilities should be readily accessible. Provide good general ventilation. Local exhaust ventilation may be necessary for some operations. If exposure limits (see Section II) can not be maintained by ventilation, use of a NIOSH approved respirator suitable for the conditions of use and chemicals in Section II should be considered. (N95 or greater is recommended)

LEAK AND SPILL PROCEDURE: Dike and contain spills with inert material (sand, earth, commercial absorbent, etc.) and transfer to containers for disposal. Keep spill out of storm sewers and waterways.

WASTE DISPOSAL METHOD: Assure conformance with regulations.

HANDLING PROCEDURES: Do not get in eyes, on skin or clothing. Do not breathe product vapor or mist. Do not swallow. Use with adequate ventilation. Wash thoroughly after handling.

STORAGE REQUIREMENTS: Keep container closed when not in use. Do not freeze. Do not store above 49°C (120°F). Do not mix with other chemicals. Keep out of reach of children.

SPECIAL SHIPPING INFORMATION: Corrosive liquids, n.o.s., 8, UN 1760, II, (contains quaternary ammonium chloride)

SECTION VIII: FIRST AID MEASURES

EYES: Immediately flush eyes with water for at least 15 minutes. Remove contact lenses. Get medical attention.
SKIN: Remove contaminated clothing and shoes. Flush skin with water for at least 15 minutes. Get medical attention. Wash contaminated clothing before reuse. Destroy contaminated shoes.
INGESTION: Call a poison control center or doctor immediately for treatment advice. Do not induce vomiting. Drink one or two glasses of water to dilute product. Do not give anything by mouth to an unconscious person.
INHALATION: In case of respiratory irritation, move person to fresh air. Get medical attention immediately.
